Public notice is hereby given that on the 13th day of September, 2024, the County Treasurer of Ashtabula County, Ohio filed a complaint in the Common Pleas Court of Ashtabula County, Ohio, for the foreclosure of liens for delinquent taxes, assessments, charges, penalties and interest against certain real property situated in such county, as described in the complaint.

Upon the filing of any entry of confirmation of sale, subject to all existing oil, gas and mineral leases, there shall be no further equity or redemption. After the filing of any such entry, any

person claiming any right, title or interest in, or lien upon, any parcel shall be forever barred and foreclosed of any such right, title, or interest in, lien upon, and any equity of redemption in such parcel.
